Guidelines

1. Please remove your child's shoes prior to entering the childcare
2. Do NOT bring a SICK child into this space
3. Notify childcare staff of any special needs of your child
4. Please note there will be no refund of the drop in or the class fee, should you have to leave at any time during the cycle class in which you are registered

By signing this waiver, the undersigned agrees that they have read the above policies and agree to adhere to the same.

Waiver and Release

By signing the waiver, the undersigned abides to all rules on behalf of the participant named above and acknowledges, and agrees to the following conditions as stated below.

1. The undersigned represents that he/she is the parent of legal guardian of the minor child named above, or he/she has obtained permission from the parent/legal guardian of the minor child named above to execute this agreement on their behalf
2. The undersigned hereby agrees that he/she and the minor child named above shall comply with all stated and customary terms, posted safety signs, rules and verbal instructions as conditions for participation in the Vortex child care.
3. If the undersigned and/or the minor child named above observes any hazard during participation of child care they shall bring it to the attention of the nearest Vortex Cycle Studio employee or official immediately.
4. The undersigned and the minor child named above hereby take full responsibility for all damages to the Vortex Cycle Studio premises and facility and any of the its contents arising from the refusal to follow all stated and customary terms, posted safety signs, rules and verbal instructions including any deliberate acts of damage and/or destruction by the undersigned and/or the minor child named above.
5. The undersigned hereby agrees that there are certain inherent risks associated with group childcare. In agreement of these risks, the undersigned and minor child named above assume full responsibility for all injuries or damage that may be caused, sustained, or aggravated by the undersigned and/or the minor child named above or any other party.
6. The undersigned agrees to allow Vortex Cycle Studio employees, staff and/or agents to perform any first aid and/or CPR upon the minor child named above should such care be required and is aware that Oregon is a Good Samaritan state
7. The undersigned and on behalf of the minor child named above, as well as their respective heirs, assigns, administrators, personal representatives and next of kin, hereby releases and hold harmless Vortex Cycle Studio and its parent and/or affiliated companies, including all officers, agents, members, employees, representatives, and all other participants, and sponsoring agencies from and against any and all claims, injuries, liabilities, or damages arising out of or related to participation in any and all Vortex Cycle Studio programs, activities, parties, whether occurring in the studio or other areas of the facility. Specifically releasing Vortex Cycle Studio from all claims, actions, suits, procedures, costs, expenses, damages, and liabilities arising out of or related to participation in any Vortex Cycle Studio related events.
8. The undersigned, grants Vortex Cycle Studio the irrevocable right to use the undersigned's and/or the minor child's name, picture, photograph, or portrait in all forms and media and in all manners, including composite for advertising, publication, social media, or any other lawful purpose, and the undersigned for himself/herself and on behalf of the minor child waives all rights to inspect or approve of any such use.
9. The undersigned acknowledges that he/she is signing this waiver on behalf of the minor child named above and freely and voluntarily and intend by their signature below for this document to be considered a complete and unconditional release of all liability to the greatest extent allowed by law.
10. Vortex Cycle Studio reserves the right to refuse services at its discretion
